### Terms and Conditions

- The Dial A Draft facility shall be available only to Primary Card Members provided that they meet Samba's criteria for issuing a Dial A Draft.
- Availability of the facility is subject to account status checking, available credit limit at the time the request is received and the final acceptance by Samba in its absolute discretion. Samba, in its discretion and without assigning any reason has the right to revise the final approved Dial A Draft amount.
- The approved Dial A Draft facility amount will be deducted from the available Credit Limit of the relevant Samba Card account upon approval of the application. The Credit Limit will be restored in accordance with the Card Member's payment.
- The Card Member shall repay the Dial A Draft amount by way of monthly minimum payments or Samba Installment Plan monthly installments as requested at the time of initiating the request of Dial A Draft.
- The amount will be disbursed by a check made in the name of a beneficiary as designated by the Card Member. For check disbursement via courier, the check will be sent to the correspondence address of the Card Member registered with Samba. Samba reserves the right to stop the check disbursement at any time as it deems fit, without assigning any reason whatsoever.
  - The issuance of a replacement Dial A Draft check to the Card Member is at Samba's discretion if the Dial A Draft check is lost, destroyed or otherwise not received by the Card Member for any reason;
  - The Dial A Draft check is not presented by the Card Member or designated beneficiary within 6 months from the date of the check; or
  - The beneficiary name as designated by the Card Member is incorrect; or the facility cannot be cancelled, changed or reversed once submitted.
- Without prejudice to other terms contained herein, if the entire statement balance stated in any monthly statement is not received in full by the payment due date, an interest charge (at the prevailing rate) will be imposed on (a) the Monthly Installment Amount from the billing date until full payment is credited to the Account; and (b) the unpaid balance and the new transactions in accordance with the Card Member Agreement. Other fees and charges as set out in the Card Member Agreement will continue to apply. For Dial A Draft amounts converted to Samba Installment Plans(SIP), SIP terms will apply and is available on [www.samba.ae](http://www.samba.ae). The SIP facility is not available for Samba Al Khair Credit Cards.
- Samba shall have the right at its absolute discretion to request for full payment of the Dial A Draft facility amount at any time. In the event of cancellation of the Account for whatever reason, the total outstanding Dial A Draft amount will become immediately due and payable.
- Samba reserves the right at any time without prior notice to vary all or any of the Terms and Conditions, or to replace, wholly or in part, the facility by another scheme, whether similar to this scheme or not, or to withdraw it altogether.
- Samba will not be responsible or liable for any actions, claims, damages, costs, charges and expenses which a Card Member may suffer, sustain or incur by way of the Program.

- A non-refundable processing fee on the Dial A Draft amount as per the current Schedule of Charges will be charged to and debited from from the Card account for each successful Dial A Draft.
